- fail to give further notices in order to bring up to date information given in this notice after my re-election or reappointment or to fail to declare a disclosable pecuniary interest that I acquire after the date of this notice and have to declare

under the provisions of s. 31 (2) of the Localism Act 2011.

I also acknowledge that it may be a breach of the Members Code of Conduct of Aldenham Parish Council to:-

- omit information that ought to be given in this notice;
- provide information that is materially false or misleading;
- fail to provide written notification to the Monitoring Officer of Hertsmere Borough Council of any change in my interests contained in this notice within 28 days of my becoming aware of such change of circumstances
